Our new partner for testing, Wisdom Health, has helped us to support new genetic tests both for health and breeding purposes. We have several exciting research grants coming up and continuing. Raise your paw if you can't wait for another Gathering at Sunnybank! CHF as a family always will find a way to make fund raising fun for all our volunteers and for all of you. All you need to do is join us!

I want to thank all the volunteers that made health testing, silent auctions, and our live auction and dinner a success. I worry every year before the National whether enough people will come and volunteer. We are running so many more things to help our members with health testing and with our need for fundraising at the National, we need more help than ever. I saw so many new helpers this year; I was elated! Some of the people were long time friends, acquaintances and even people I had never met before. Whether you were polishing silver or making out silent auction cards, everyone deserves a big thanks. You all know who you are so give yourself a pat on the back! I'm always afraid to name names because I might leave someone out, but know your help was essential to our success and greatly appreciated. We also have the usual suspects who man the tables through thick and thin. I want you to know I can never thank you enough for always being there.

We tried something new this year and had a couple of separate auctions on specialty items that would have normally been in the night auction. One of the items was a beautiful quilt where we left the silent auction open for two days. We had a couple of our "Vannas" gliding around the convention center giving even more people the opportunity to bid. We made \$5,574 on the silent auctions! Thursday night at our presentation, dinner and live auction, we started with a few technical problems, but we were lucky enough to be entertained by dancing, money grabbing Collies! During the cocktail hour, our own Dr. Nancy Kelso gave a wonderful talk on the differences in OFA and PennHIP. We had her talk recorded again this year. You can see it on our YouTube channel. I think the banquet dinner was one of the best we have had. We had so many spectacular items at the night auction, it was unbelievable. A big thank you to Shelley and her

brother Ron Roos for donating the Wickmere collection in memory of their parents, Bobbee and George Roos. I would like to thank again all the donors who donated things to CHF for this year's National. We made \$11,220 at the live auction. The good news is, if you missed this year, we have a few items left over for Syracuse.

This year's Martha E. Hoffman CHIC DNA Banking Project was another huge success. Dr. Nancy Kelso manned the fort and we had two new Veterinarians help that I had never met. We had many volunteers including vet techs to help. Thank you for finding time almost each day to help! We had 105 Collies participate in this year's clinic. This puts us up to 336 Collies banked with blood, 16 swabs banked, and 48 applications turned in, but no follow up or blood that has been received at the lab. For those of you who have turned in applications, please get your dogs banked as soon as possible. I will give you some updates on some of the diseases and health issues that have been registered with CHIC through this banking in our next newsletter. DNA banking is an important step to preserving the Collie breed. We are using CHIC as our data base and it will help our grant committee, lead by Dr. Kelso, identify which areas of health that we need to focus on. It's extremely important that you update your dog's information when there is a health issue, though CHIC does not need to know if your dog passed away if there was no change in health from the date of banking. Remember, it will help cut down the time for a researcher to find the next genetic health test or allow you to test a deceased Collie when new tests become available. CHF reimburses your costs up to \$125 a dog.

This was the first year we offered a collection clinic for the Optimal Selection™ test by Wisdom Health. We worked closely with Wisdom Health to provide our members a low-cost way for testing. CHF offers a \$90 rebate for the test and an additional \$20 rebate if you purchase the CEA test after you receive your results. Thanks to a discount that Wisdom Health offered our members, there was a total of 383 Collies tested over that three-week period around the National. I want to acknowledge the volunteers that helped David Hansen DVM and Steve Johns with the clinic. I saw a lot of first-time volunteers. I hope this is not your last time volunteering!!!

Personally, on a sad note for me, we lost our Promotional item committee, Chair Chandra Flaim and Genee Foulkes. Thank you, ladies, for doing an outstanding job over the last several years. This is a very time-consuming job. It means these ladies have given up space in their homes, room in their vehicles and lots of time at Sunnybank and the National to run the merchandise table. Chandra is still helping CHF in other ways. She did our ad for Promos in this newsletter. I hope that Genee will volunteer again when her health improves, and her children get a little older! Thanks again for your hard work.

Dr. Leigh Anne Clark is working diligently on finding a modifier gene for DMS. She needs more senior dogs with the AA/bb DMS risk assessment result. She has started the research into epilepsy in Collies. There is information on page 6 of the newsletter for who to contact to participate in these very important research projects. We will be working with AKC/CHF again on a new clinical trial to investigate treatment options for DMS. This is so exciting to me since I am among the unlucky breeders who first encountered this horrible disease around 1990. As soon as we get contracts finalized, I will inform our membership about the project and how you can help. We will be working with the American Shetland Sheepdog Association too. I hope by doing this we will be able to find enough dogs diagnosed with DMS to make this trial worthwhile.

I hope to see all of you in August at "The Gathering at Sunnybank". This has become one of the most beloved events for Collie Fanciers from around the world. The Madam, Gerrie Oliver, has made special plans to surprise all of us again this year. My favorite is to see what the cake looks like each year! We always need volunteers so speak up! We train you on the job, no experience necessary.

I'm very excited where we are today and the future ahead of us. Remember we can't do any of this without you. The rebates and the Martha E Hoffman CHIC DNA Banking Project would not have the financial support if it wasn't for a few of our members trusting the Collie Health Foundation's mission and remembering us in their wills. Remember, CHF is always about the Collie. Thanks for being a part of our family!

Report on Rebates

From January 1 through July 11, 2019, CHF has issued rebates in the amount of \$1,300 for CEA tests, \$10,490 for DMS tests, \$1,400 for MDR1 tests, and \$1,950 for PRA tests. In addition, \$601.75 was paid in rebates for CHIC DNA banking and \$37,010 was paid in rebates for the Optimal Selection™ test by Wisdom Health. Finally, \$490 was paid in rebates for x-rays submitted to OFA. **In all, the Collie Health Foundation returned \$53,241.75 in rebates to members!** Keep up the good work. Let's continue to make a difference through health testing!

Krista has provided the following information to help make the rebate process as smooth and timely as possible:

As I am learning this new role, I am finding that there are submissions for rebates that are easy to process and others who take a great deal more time. The process of paying rebates involves many steps which is complicated. I thought I would offer some tips that will help everyone, myself included, receive the rebates in the fastest time possible. Here goes...

- 1). Submit your receipts in the name that your membership is in and you must own or co-own the dog.
- 2). If you are able, scan your receipts in one PDF and attach it to your email.
- 3). OptiGen rebates for DMS and PRA-rcd2 requires a copy of the results on OptiGen Letter head and signed. If you are concerned about privacy, feel free to black out the results,
- 4). Optimal Selection rebates require either the email that you receive from OS that confirms that your swab(s) have been received or the first page of the results.
- 5). CHIC repository rebates require that the DNA submitted is blood.
- 6). OFA/PennHIP rebates require either your veterinarian's bill itemized showing the submission fee, or the certificate for your dog's results.
- 7). Indicate in your email how you prefer to receive your rebate...by check or PayPal. If you choose PayPal, please verify your PayPal email address.
- 8). Checks mailed outside the US cannot be guaranteed, therefore you will be responsible for any bank fees to replace the check.
- 9). If Optimal Selection offers you a PRA test...do not buy it! This is not the test for Collies. The only PRA test is the Rcd2-PRA that applies to Collies.
- 10). If you are going to have the CEA add-on test run, please wait until you have all results (Optimal Selection and the CEA). to submit together...just makes it easier to process.
- 11). Please don't let rebates pile up...send them in as you do them.

Additional notes:

Optimal Selection is in the process of running studies to be able to process DMS and PRA-rcd2. Sometime in the near future, OptiGen will no longer be doing these tests. We have assurance that OptiGen will not phase out until Optimal Selection is up and running on those tests. If you'd like to do those two tests with OptiGen, get them submitted now. We don't know exactly when the changeover will occur.

Final Grant Reports

Andrea Fiumefreddo, Director of Programs, AKC Canine Health Foundation has provided final reports on a couple of AKC grants the Collie Health Foundation has helped to fund.

Grant 02257: Identification of Genetic Risk Factors for Canine Epilepsy

Principal Investigator: Gary Johnson, DVM, PhD; Research Institution: University of Missouri, Columbia

Original Project Description: Epilepsy is one of the most common neurologic diseases of dogs and a top concern of dog breeders. Despite strong evidence that genetics is important in determining the risk of idiopathic epilepsy, numerous gene mapping studies have failed to identify a locus that accounts for that risk in either dogs or humans. Seizures occur when excessive activity goes beyond the normal threshold for brain function, many factors contribute to that level of activity, and therefore, mutations in numerous genes may collectively contribute to increased activity until that threshold is exceeded, resulting in epilepsy. Any one of these mutations may be present in non-epileptic dogs, but because it only partially alters activity, it would not produce seizures. Therefore, traditional gene mapping studies might overlook that mutation. Using a novel whole genome sequencing approach the investigators hope to identify DNA variations in epileptic dogs that could affect the function of genes such as ion channels and neurotransmitter receptors that have been shown to alter the seizure threshold in humans or rodents. The frequency of such variations in populations of epileptic and non-epileptic dogs will be directly compared rather than the indirect markers used in traditional mapping studies. The increased power provided by looking for specific gene candidate variations rather than linked markers will aid the identification of epilepsy risk factors, perhaps leading to development of DNA tests to enable breeders to select against such risk factors.

Final Report to Grant Sponsor from Investigator: This investigation of canine epilepsy had two objectives: (1) to identify genetic variation that occurs within a single breed and increases the chances for breed members to develop epilepsy; and (2) to identify genetic variation that occurs in many breeds and increases the chances of developing epilepsy for any dog that carries the variation. For objective 1, we first determined entire genome sequences for 28 epileptic dogs from 19 different breeds. Computer analysis was used to determine which of the millions of DNA sequence variations in each of these genome sequences, were likely to alter the functions of genes previously associated with epilepsy in human patients or animal models. We selected eight of the variants considered most likely to be epilepsy risk factors and did DNA tests to see if the variants were more common in epileptic dogs than in non-epileptic dogs from the same breed. For four of these variants, the DNA test results suggested that they were not epilepsy risk factors. DNA test results for the other four variants suggested that they may be breed-specific epilepsy risk factors; however, one of them was too rare to be useful even within the affected breed. Another of these variants appears to slightly increase epilepsy risk but is too common to be of practical use. Breeding strategies that avoid this risk factor would eliminate much of the breed's gene pool. The remaining two potential epilepsy risk factors show promise and are the subjects of ongoing investigation. For the second objective (identification of genetic risk factors for epilepsy that occur in multiple breeds), we did a computer screen for potential epilepsy risk factors in over 150 genome sequences, mostly from dogs with diseases other than epilepsy. We then selected the 55 variants considered most likely to be epilepsy risk factors and tested for the concentrations of these variants in pooled DNA samples from 604 epileptic dogs representing 33 different breeds. The concentrations of these variants were also measured in pools of DNA from 604 breed and gender matched non-epileptic dogs that reached at least their eighth birthday without a history of seizures. The concentrations of 3 of the variants were significantly higher in the epilepsy pools compared to the control pools. These three potential epilepsy risk factors should be validated with other collections of DNA samples from epileptic and non-epileptic dogs before used to for mate selection.

Grant 02287: Enhanced Testing for the Diagnosis of Bartonellosis in Dogs

Principal Investigator: Edward Breitschwerdt, DVM; Research Institution: North Carolina State University

Original Project Description: Bartonellosis, a zoonotic bacterial disease of worldwide distribution, is caused by approximately 10 different Bartonella species. Bartonella are transmitted to canines and humans by ticks, fleas, lice, mites, and sand flies. Dr. Breitschwerdt's laboratory demonstrated the first evidence for Bartonella infections in dogs in 1993. Bartonella species have been associated with an expanding spectrum of important disease manifestations including anemia, endocarditis, hepatitis, lymphadenitis, myocarditis, thrombocytopenia and vascular tumor-like lesions. Infections can be life-threatening. Due to a lack of sensitive and reliable diagnostic assays, definitive diagnosis of bartonellosis in dogs remains a significant problem. Because these bacteria invade cells and infect tissues throughout the body, this chronic intracellular infection is difficult to cure with currently used antibiotic regimens. This study will develop improved serodiagnostic tests for bartonellosis in dogs. These assays can also be used for world-wide sero-epidemiological prevalence studies, and to establish early and accurate diagnosis. Dr. Breitschwerdt's research group has described concurrent infection in dogs, their owners and veterinary workers; this allows for a One Health approach to this important emerging infectious disease.

Final Report to Grant Sponsor from Investigator: This AKC-CHF funded research has resulted in substantial refinement of our Bartonella serodiagnostic testing knowledge of healthy dogs (pets, working dogs and potential blood donors) and sick dogs being evaluated for a differential diagnosis of Bartonellosis. Based upon testing and comparing results using eight different Bartonella species or strains, we were able to identify two species that when used in combination should increase serodiagnostic sensitivity compared to the three strains that we have used diagnostically for the past decade. As these are not the two species currently in use diagnostically, our historical testing most likely underestimated the prevalence of Bartonella antibodies in seroepidemiological studies published by our research group and more importantly failed to report positive Bartonella spp. serological results that could be used to guide therapy in a sick dog. In both our research and diagnostic laboratory testing, we have always adhered to the adage: The kindest form of therapy is an accurate diagnosis. This study also allowed us to begin to assess the utility of another serodiagnostic technique called Western immunoblotting for assessment of a dog's exposure to a Bartonella spp. WB interpretation can be challenging and this study has allowed us to compare IFA and WB sensitivities and to define minimal criteria for reporting a "positive" WB. Our efforts to date have identified individual and potential combinations of small Bartonella proteins (peptides) that appear to have diagnostic utility as an inhouse rapid assay that could be used by veterinarians to rapidly determine if a dog has been exposed to a Bartonella spp. We are currently purifying individual proteins and assessing other peptide combinations in an effort to define an assay with optimal sensitivity and specificity. This brief paragraph does not do justice to the numerous hours of research effort that was made possible because of the research funding support from the American Kennel Club Canine Health Foundation or the dogs and their owners who will ultimate benefit from these findings, as we improve serodiagnosis of bartonellosis.
